Subject: Establishment of the San Luis Valley Public Lands Center, CO-500

I am pleased to announce that effective April 18, 2004, BLM and Forest Service organizations in the San Luis Valley will be combined to create the San Luis Valley Public Lands Center. Peter Clark, Rio Grande National Forest Supervisor, will serve as the new San Luis Valley Public Lands Center Manager, and Jim Rhett, Front Range Center Associate Manager, will serve as the new San Luis Valley Public Lands Center Associate Manager.

The ultimate vision for public land administration in the San Luis Valley is to provide the most efficient, effective management of public and national forest system lands in the area. Our objective is to provide an integrated organization that ensures one-stop service to customers through the proficient use of personnel and funding resources to more effectively and proficiently manage land and natural resources. The geography, ecosystems, land uses, and land ownership patterns in the Valley are perfect for seamless management of public and national forest system lands across the landscape.

As a result of this action, the Front Range Center will be abolished. Employees assigned to the Front Range Center, CO-500, and the Front Range Center Fire Staff, CO-502, will be realigned to the Royal Gorge Field Office, CO-200. Employees assigned to the Front Range Center Detached Office, CO-501, will be realigned to the new San Luis Valley Public Lands Center, CO-500. Employees assigned to the La Jara, Saguache, and Del Norte Field Offices will not be affected by this organizational change.

I would like to thank Roy Masinton, Front Range Center Manager, Jim Rhett, Front Range Center Associate Center Manager, and Pete Clark, Forest Supervisor, for their leadership during the past 18 months while we went through the process of establishing the San Luis Valley Public Lands Center and for their on-going support of Service First. I would also like to thank all those employees who worked through the myriad of details required to implement this new Center.
