Subject to approval by the BLM, (CA Operator) hereby designates (CA Co-operator) as its Co-operator for the conduct of all operations for the following Communitization Agreement well(s):

This Designation of Co-operator hereby confers on (CA Co-operator) all of the rights, benefits, and privileges of (CA Operator), as CA Operator, for said well(s), subject to the duties, obligations, and liabilities of the (CA Operator) under the above-described CA to the extent they apply to all operations concerning the well(s) described above with full authority to act as Operator in complying with the terms and conditions of the CA and the underlying leases, the applicable federal laws and regulations, and on whom the Authorized Officer (AO) of the BLM may serve written or oral instructions and orders in securing compliance with the federal oil and gas regulations.

(CA Co-operator) acknowledges and agrees to assume all obligations and responsibilities as Co-operator for the above-referenced CA well(s) and agrees to comply with all the terms and conditions of the CA and the underlying leases, and all applicable federal laws and regulations.

It is specifically understood that this Designation of Co-operator does not relieve (CA Operator) of ultimate responsibility for compliance with the terms and conditions of the CA and the underlying leases, and the applicable federal laws and regulations as they apply to the above-referenced well(s).

This Designation of Co-operator does not constitute an assignment of any interest in the underlying leases.

In the case of default on the part of the designated Co-operator the CA Operator will make prompt resolution and compliance with the terms and conditions of the CA and underlying leases, all applicable federal laws and regulations, and instructions and orders of the AO.

In the event that a Successor CA Operator is approved, the Co-operator as herein designated will continue to be recognized by the new CA Operator and the BLM.

A designated Co-operator may not designate another party as Co-operator. This authority is vested solely with the CA Operator subject to approval by the BLM.

This agreement shall be binding upon the parties hereto, their successors, heirs, and assigns.
