

This is within hunting units 16, 17, and 171.




# Orion Multimedia Film Permit Jackson County COC-76658

3. Access to and from the site will not occur during periods of wet soil conditions where rutting in excess of 2 inches occurs.
4. The Kremmling Field Office will be notified of any delay or change in dates for the project.
5. The Kremmling Field Office will be notified when filming is complete.
6. Permittee shall own all rights of every kind in and to all photographs and recordings made by it on public lands and shall have the right to use such photographs and/or recordings in any manner it may desire without limitation or restriction of any kind.
