DESCRIPTION OF PROPOSED ACTION: Red Rock Gathering Company (formerly ETC Canyon) has requested rights-of-way for surface pipelines to SW Rangely Federal 12-4-1-102, 24-4-1-102, 17-4-1-102, 14-4-1-102 (See maps 1-4). These steel surface pipelines currently exist and were installed by Carbon Energy when they were the operator of the lease. Red Rock Gathering now operates these pipelines and requires rights-of-way for operation.

PLAN CONFORMANCE REVIEW: The Proposed Action is subject to and has been reviewed for conformance with (43 CFR 1610.5-3, BLM 1601.08) the following plan:

CATEGORICAL EXCLUSION REVIEW: The Proposed Action qualifies as a categorical exclusion under 516 DM 11.9, E16: *“Issuances of leases, permits, or rights-of-way for the use of existing facilities, improvements, or sites for the same or similar purposes.”*

REMARKS:

Cultural Resources: C-76263: The proposed well pad (12-4-1-102) access route that the surface pipeline follows was inventoried at the Class III (100 percent) pedestrian level (Montgomery 2001 compliance dated 4/11/2001). However, the access road and surface pipeline tie do not lie completely within the area identified for cultural inventory and inventoried for cultural resources. Therefore, if any soil disturbing activities are proposed involving the pipeline, the proposal must be evaluated on a case-by-case basis to determine if additional cultural work is required to comply with preservation laws.

C-76264: The proposed well pad (24-4-1-102) and access route that the surface pipeline follows was inventoried at the Class III (100 percent pedestrian) level (Montgomery 2001 compliance dated 4/11/2001). However, the road and pipeline route do not follow the route as inventoried for cultural resources. Therefore, if any soil disturbing activities are proposed involving the pipeline, the proposal must be evaluated on a case-by-case basis to determine if additional cultural work is required to comply with preservation laws.

C-76265: The proposed well pad (17-4-1-102) access route the surface pipeline follows was inventoried at the Class III (100 percent pedestrian) level (Montgomery 2001 compliance dated 4/11/2001). However the route, as built, does not follow the route inventoried for cultural resources. Therefore, if any soil disturbing activities are proposed involving the pipeline, the proposal must be evaluated on a case-by-case basis to determine if additional cultural work is required to comply with preservation laws.

C-76266: The proposed route of the surface pipeline was inventoried at the Class III (100 percent pedestrian) level (Ball 2001 compliance dated 6/14/2001, Montgomery 2001 compliance dated 4/11/2001). However, the route, as built does not follow the route inventoried for cultural resources. Therefore, if any soil disturbing activities are proposed involving the pipeline, the proposal must be evaluated on a case-by-case basis to determine if additional cultural work is required to comply with preservation laws.

Native American Religious Concerns: The ROW renewals involve no new ground disturbance and should not involve any new impacts to known properties that might be of interest to Native American Groups. No Native American religious concerns are known in the area, and none have been noted by Northern Ute Tribal authorities. Should recommended inventories or future consultations with Tribal authorities reveal the existence of such sensitive properties, appropriate mitigation and/or protection measures may be undertaken.

Paleontological Resources: All of the ROW renewals are located in an area generally mapped as the Upper Mesa Verde Unit (Tweto 1979) which the BLM has classified as a Potential Fossil Yield Classification (PFYC) 5 formation meaning it is known to produce scientifically noteworthy fossil resources (c. Armstrong and Wolny 1989). Renewal of the ROWs should not present any new impacts to paleontological resources; however, weathering could expose previously unknown resources along the ROW that could be impacted by pipeline use and maintenance activities. Impact to recently exposed fossil could result in a long term, permanent, irreversible and irretrievable loss of scientific data from the regional paleontological database.

Special Status Wildlife Species: There are no wildlife-related issues or concerns associated with the Proposed Action.

Special Status Plant Species: There are parts of the existing ROW that are located near potential habitat for BLM sensitive plant species. The project area is largely un-surveyed and little is known about what sensitive species actually exist in that area. With no disturbance occurring at this time, there are no special status plant species concerns associated with the Proposed Action. However, if maintenance is required in the future and disturbance will be occurring, special status plant surveys will be required prior to any disturbance. See Mitigation #1 below.

MITIGATION:

1. The holder shall notify the authorized officer at least 60 days prior to non-emergency activities that would cause surface disturbance in the right-of-way. A "Notice to Proceed" shall be required prior to any non-emergency activities that would cause surface disturbance on the right-of-way. Any request for a "Notice to Proceed" must be made to the authorized officer, who will review the proposed action for consistency with resource management concerns such as wildlife, big game winter range, paleontology, special status species, and cultural resource protection. The authorized officer may require the completion of special status species surveys or other resource surveys by a third party contractor at the expense of the holder. Additional measures may be required to protect special status species or other resources.

2. The holder is responsible for informing all persons who are associated with the project that they will be subject to prosecution for knowingly disturbing archaeological sites or for collecting artifacts.

3. If any archaeological materials are discovered as a result of operations under this authorization, activity in the vicinity of the discovery will cease, and the BLM WRFO Archaeologist will be notified immediately. Work may not resume at that location until approved by the AO. The holder will make every effort to protect the site from further impacts including looting, erosion, or other human or natural damage until BLM determines a treatment approach, and the treatment is completed. Unless previously determined in treatment plans or agreements, BLM will evaluate the cultural resources and, in consultation with the State Historic Preservation Office (SHPO), select the appropriate mitigation option within 48 hours of the discovery. The holder, under guidance of the BLM, will implement the mitigation in a timely manner. The process will be fully documented in reports, site forms, maps, drawings, and photographs. The BLM will forward documentation to the SHPO for review and concurrence.

4. Pursuant to 43 CFR 10.4(g), the holder must notify the AO, by telephone and written confirmation, immediately upon the discovery of human remains, funerary items, sacred objects, or objects of cultural patrimony. Further, pursuant to 43 CFR 10.4(c) and (d), the holder must stop activities in the vicinity of the discovery and protect it for 30 days or until notified to proceed by the AO.

5. The holder is responsible for informing all persons who are associated with the project operations that they will be subject to prosecution for disturbing or collecting vertebrate fossils, collecting large amounts of petrified wood (over 25lbs./day, up to 250lbs./year), or collecting fossils for commercial purposes on public lands.

6. If any paleontological resources are discovered as a result of operations under this authorization, the holder or any of his agents must stop work immediately at that site, immediately contact the BLM Paleontology Coordinator, and make every effort to protect the site from further impacts, including looting, erosion, or other human or natural damage. Work may not resume at that location until approved by the AO. The BLM or designated paleontologist will evaluate the discovery and take action to protect or remove the resource within 10 working days. Within 10 days, the operator will be allowed to continue construction

through the site, or will be given the choice of either (a) following the Paleontology Coordinator's instructions for stabilizing the fossil resource in place and avoiding further disturbance to the fossil resource, or (b) following the Paleontology Coordinator's instructions for mitigating impacts to the fossil resource prior to continuing construction through the project area.

7. The holder shall conduct all activities associated with the operation and termination of the right-of-way within the authorized limits of the right-of-way.

8. Any proposal involving additional surface disturbance outside of the authorized right-of-way requires an application to the BLM for analysis and authorization. New stipulations for construction would be applied to projects subject to the regulations and policies existing at the time of authorization.

9. The holder shall monitor all disturbed and reclaimed areas through final abandonment for the presence of invasive, non-native, and/or noxious plant species. The applicant will be responsible for eradication of noxious weeds that occur on site using materials and methods approved in advance by the Authorized Officer.

COMPLIANCE PLAN: On-going compliance inspections and monitoring will be conducted by the BLM White River Field Office staff during and after construction. Specific mitigation developed in this document will be followed. The operator will be notified of compliance related issues in writing, and depending on the nature of the issue(s), will be provided 30 days to resolve such issues.



Red Rock Gathering Surface Pipeline COC76263





Red Rock Gathering Surface Pipeline COC76266








DECISION RECORD

PROJECT NAME: Red Rock Gathering Surface Pipelines

CATEGORICAL EXCLUSION NUMBER: DOI-BLM-CO-110-2013-0127-CX

DECISION

It is my decision to implement the Proposed Action, as mitigated in DOI-BLM-CO-110-2013-0127-CX, authorizing the operation, and maintenance of four existing steel surface pipelines to SW Rangely Federal 12-4-1-102, 24-4-1-102, 17-4-1-102, and 14-4-1-102.

Mitigation Measures

1. The holder shall notify the authorized officer at least 60 days prior to non-emergency activities that would cause surface disturbance in the right-of-way. A "Notice to Proceed" shall be required prior to any non-emergency activities that would cause surface disturbance on the right-of-way. Any request for a "Notice to Proceed" must be made to the authorized officer, who will review the proposed action for consistency with resource management concerns such as wildlife, big game winter range, paleontology, special status species, and cultural resource protection. The authorized officer may require the completion of special status species surveys or other resource surveys by a third party contractor at the expense of the holder. Additional measures may be required to protect special status species or other resources.
2. The holder is responsible for informing all persons who are associated with the project that they will be subject to prosecution for knowingly disturbing archaeological sites or for collecting artifacts.
3. If any archaeological materials are discovered as a result of operations under this authorization, activity in the vicinity of the discovery will cease, and the BLM WRFO Archaeologist will be notified immediately. Work may not resume at that location until approved by the AO. The holder will make every effort to protect the site from further impacts including looting, erosion, or other human or natural damage until BLM determines a treatment approach, and the treatment is completed. Unless previously determined in treatment plans or agreements, BLM will evaluate the cultural resources and, in consultation with the State Historic Preservation Office (SHPO), select the appropriate mitigation option within 48 hours of the discovery. The holder, under guidance of the BLM, will implement the mitigation in a timely manner. The process will be fully documented in reports, site forms, maps, drawings, and photographs. The BLM will forward documentation to the SHPO for review and concurrence.

4. Pursuant to 43 CFR 10.4(g), the holder must notify the AO, by telephone and written confirmation, immediately upon the discovery of human remains, funerary items, sacred objects, or objects of cultural patrimony. Further, pursuant to 43 CFR 10.4(c) and (d), the holder must stop activities in the vicinity of the discovery and protect it for 30 days or until notified to proceed by the AO.

5. The holder is responsible for informing all persons who are associated with the project operations that they will be subject to prosecution for disturbing or collecting vertebrate fossils, collecting large amounts of petrified wood (over 25lbs./day, up to 250lbs./year), or collecting fossils for commercial purposes on public lands.

6. If any paleontological resources are discovered as a result of operations under this authorization, the holder or any of his agents must stop work immediately at that site, immediately contact the BLM Paleontology Coordinator, and make every effort to protect the site from further impacts, including looting, erosion, or other human or natural damage. Work may not resume at that location until approved by the AO. The BLM or designated paleontologist will evaluate the discovery and take action to protect or remove the resource within 10 working days. Within 10 days, the operator will be allowed to continue construction through the site, or will be given the choice of either (a) following the Paleontology Coordinator's instructions for stabilizing the fossil resource in place and avoiding further disturbance to the fossil resource, or (b) following the Paleontology Coordinator's instructions for mitigating impacts to the fossil resource prior to continuing construction through the project area.

7. The holder shall conduct all activities associated with the operation and termination of the right-of-way within the authorized limits of the right-of-way.

8. Any proposal involving additional surface disturbance outside of the authorized right-of-way requires an application to the BLM for analysis and authorization. New stipulations for construction would be applied to projects subject to the regulations and policies existing at the time of authorization.

9. The holder shall monitor all disturbed and reclaimed areas through final abandonment for the presence of invasive, non-native, and/or noxious plant species. The applicant will be responsible for eradication of noxious weeds that occur on site using materials and methods approved in advance by the Authorized Officer.

COMPLIANCE WITH LAWS & CONFORMANCE WITH THE LAND USE PLAN

This decision is in compliance with the Endangered Species Act and the National Historic Preservation Act. It is also in conformance with the 1997 White River Record of Decision/Approved Resource Management Plan.

PUBLIC INVOLVEMENT

The BLM informed the public about this project by listing it on the online WRFO NEPA Register on 11/15/2013 and a copy of the completed Categorical Exclusion will be posted on the WRFO website.

RATIONALE

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with 516 DM 11.9, E16. This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The Proposed Action has been reviewed, and none of the extraordinary circumstances described in 43 CFR 46.215 apply.

ADMINISTRATIVE REMEDIES

This decision shall take effect immediately upon the date it is signed by the Authorized Officer and shall remain in effect while any appeal is pending unless the Interior Board of Land Appeals issues a stay (43 CFR 2801.10(b)). Any appeal of this decision must follow the procedures set forth in 43 CFR Part 4. Within 30 days of the decision, a Notice of Appeal must be filed in the office of the Authorized Officer at White River Field Office, 220 East Market St., Meeker, CO 81641 with copies sent to the Regional Solicitor, Rocky Mountain Region, 755 Parfet St., Suite 151, Lakewood, CO 80215, and to the Department of the Interior, Board of Land Appeals, 801 North Quincy St., MS300-QC, Arlington, VA, 22203. If a statement of reasons for the appeal is not included with the notice, it must be filed with the Interior Board of Land Appeals at the above address within 30 days after the Notice of Appeal is filed with the Authorized Officer.
