If you wish to withhold personal identifying information from public review or disclosure under the Freedom of Information Act (FOIA), you must clearly state, in the first line of your written comment, “CONFIDENTIALITY REQUESTED.” While you can ask us in your comment to withhold your personal identifying information from public review, we cannot guarantee that we will be able to do so. All submissions from organizations, from businesses, and from individuals identifying themselves as representatives of organizations or businesses, will be available for public review.

Under the column "Comment Period," Y means there is a formal comment period during a definite period. N means there is no formal comment period and comments should be submitted prior to the estimated decision date. Please feel free to provide comments to or request information from the contact identified on the log.
