The boundaries of this unit are mainly defined by surrounding State and private lands. This is an irregular shaped unit with two small private inholdings within the central portion.

This unit contains a maintained road in the northern portion as well as a well-used route which accesses deeded land.

There is a power transmission line that runs through the southern part of the unit and one plugged and abandoned well in the northern portion.

Portions of 7 grazing allotments fall within the inventory unit with approximately 6 miles of interior fences and several small reservoirs scattered throughout.

During team review, the inventory unit was determined to not meet the apparent naturalness criteria of wilderness characteristics for the above reasons.
