The area is bordered by Bentonite Road on the north, Arranbide Road on the east, around a state section to Burnett Spur road continuing west back to Bentonite Road. There is one State inholding.

The unit is cut in half by the bentonite haul road. There are active mine claims with well-traveled routes leading to them. There are currently a total of 249 bentonite mine claims.

There are portions of 4 grazing allotments within the unit with over 10 miles of interior fence and approximately 10 miles of vehicle routes. The unit also contains some large reservoirs and one plugged and abandoned well.

There is one plugged and abandoned well in this unit.

During team review, the inventory unit was determined to not meet the apparent naturalness criteria of wilderness characteristics for the above reasons.
