The area is bordered by little Beaver Road on the northwest, Wilderness Road on the east, and Triple Crossing Access Road on the south.

The unit is bordered by well-maintained, well-traveled gravel roads to the west and north, TC Access and Beaver Branch Roads respectively. The Beaver Branch road can be seen and heard from nearly the entire unit because of the topography. The bag and fence enclosure for the I-19 Pipeline is skylined on the south ridge. There is also a large retention/waterfowl reservoir (Itcaina Reservoir) in the northwest corner of the unit. There are 3 water tanks with maintenance trails from the I-19 Pipeline in the middle portion of the unit.

All or portions of 3 grazing units with approximately 4 miles of interior fence are located within the inventory area.

During team review, the inventory unit was determined to not meet the apparent naturalness criteria of wilderness characteristics for the above reasons.
