

## Montana/Dakotas BLM Travel Planning Contacts

The 2003 Record of Decision for the *Off-Highway Vehicle (OHV) Environmental Impact Statement and Proposed Plan Amendment for Montana, North Dakota and South Dakota* directed the BLM to identify and prioritize travel planning areas as “high,” “moderate,” or “low.” This process was completed in December 2003. The BLM listed 19 planning areas as high priority and 23 areas as moderate.

The Butte and Dillon field offices are addressing travel management in their resource management plans (RMPs) and have listed their entire field offices as OHV priority areas. The Missoula Field Office has completed travel management planning.

Site specific travel management planning outside the RMP revision process has been initiated in the remaining offices in Montana and the Dakotas.
