The Bureau of Land Management (BLM) is providing you with an unsigned copy of the Environmental Assessment (EA) for the ConocoPhillips Company, San Juan 29-6 #61M, NMSF078426.

The ConocoPhillips Company has indicated their intent to drill the above well within the BLM Farmington Field Office (FFO), San Juan County, New Mexico. The proposed well project would be located within the following Areas of Critical Environmental Concern (ACECs):

- San Rafael Cultural

The project area is located within portions of sections 19 of Township 29 North, Range 06 West, New Mexico Principle Meridian (NMPM).

The enclosed document serves as notice of the environmental analysis process to fulfill the requirement of the National Environmental Policy Act. A 20 work-day public comment period will begin on **September 8, 2010** and end **October 6, 2010**.
