Witnesseth: Whereas under the provision of sec. 17(j) of the Act of February 25, 1920, as amended (74 Stat. 784; 30 U.S. C. 266(J), and by the authority delegated, the Bureau of Land Management (**could be USGS, remove this**) on the 1st day of April, 1972 , approved Communitization agreement no. OKNM123456 whereby DEF Resources, Inc. (original operator), is designated as Operator of the communitized area; and

Now, therefore, in consideration of the premises hereinbefore set forth and the promises hereinafter stated, the First Party hereby covenants and agrees to fulfill the duties and assume the obligations of Operator of the communitized area under and pursuant to all the terms of Communitization Agreement number OKNM123456 and the Second Parties covenant and agree that effective as of the date herein specified, and upon receipt of this indenture, properly executed, by the Authorized Officer, First Party shall be granted the exclusive right and privilege of exercising any and all rights and privileges as Operator, pursuant to the terms and conditions of said communitization agreement, said communitization agreement being hereby incorporated herein by reference and made a part hereof as fully and effectively as though said agreement were expressly set forth in this instrument.
