

RATIONALE/JUSTIFICATION:

- **Items 1-6** – The naming of the Gordy's Hill SRMA violates BLM policy, which does not allow a feature or location to be named after a living person. The area has been referred to, historically, as Johnson (Gordy's) Hill, and the SRMA will also be named after the geographical feature.
