1                   EVELYN TEMOKE-ROCHE: 1745 Silver Eagle  
2 Drive, Elko, Nevada 89801. I do not understand why  
3 the water is being removed from northeastern Nevada  
4 to water the Las Vegas area. We live here. We need  
5 the water to survive. We're on water restrictions.  
6 We have animals that need water. And my fear are  
7 earthquakes once the water is removed from one area,  
8 which is going to leave a -- the water is not going  
9 to come back. It's going to be -- the caverns are  
10 going to be empty.

11                   I see no feasibility in this. I feel very  
12 strongly that they not remove water from this area to  
13 take care of another area. That area needs to -- it  
14 irritates me that they feel that they can just come  
15 in and do this. They can't. I totally oppose it.  
16 We need to survive.

17                   And with the current restrictions, it's hard  
18 for me to keep my lawn green because I have to water  
19 every other day. I have lived in California where we  
20 had water restrictions and we didn't water. We  
21 flushed the toilet, took quick baths and all that but  
22 I don't want to do that again. This may be what  
23 they're doing in Las Vegas but I don't want it  
24 happening here.

25                   It's logic. They're not using it. Anybody

1 with logic knows that when you take from one place  
2 and put it in another, that place they took from  
3 eventually doesn't work. We may have to find a way  
4 to take from the ocean or anything or we may have to  
5 refer back to that movie Dune.
