The operator or lessee may be required to conduct additional surveys or modify proposals for lease operations to protect such resources. The BLM may deny activities that are likely to result in adverse impacts to protected paleontological resources that cannot be successfully avoided or mitigated. Prior to any authorization of surface-disturbing activities on the lease, the BLM may be required to coordinate with the University of Nebraska State Museum (see the BLM's Nebraska Resource Management Plan, pages 11-12 (1992)).
