### **Offer and Deferral Summary Table**

As part of the February 2015 lease sale preparation process, the BLM WSO conducted screening for Greater Sage-Grouse per BLM WY guidance (IM WY-2012-019), consistent with national policy. The parcels meeting criteria for core habitat and manageability using the Fluid Mineral Leasing Screen were identified for deferral on this basis. As a result, of the 52 parcels reviewed in the Sage-Grouse screening process, 1 partial parcel and 27 full parcels, totaling 44,748.840 acres were screened out from lease offering at this time and are not further analyzed in detail.
