Offer and Deferral Summary Table

February 2016 Lease Parcel EA DOI-BLM-WY-R000-2015-0002-EA

As part of the February 2016 lease sale preparation process, the BLM WSO conducted screening for Greater Sage-Grouse per BLM WY guidance (IM WY-2012-019), consistent with national policy, for parcels in the Bighorn Basin. The parcels meeting criteria for core habitat and manageability using the Fluid Mineral Leasing Screen were identified for deferral on this basis. Deferred parcel areas will remain deferred from leasing until conservation planning and management potential can be evaluated in the context of a Land Use Planning Action. As a result, five parcels (four partial parcels and one whole parcel) located in the Bighorn Basin planning area totaling 2,905.210 acres, were screened out from lease offering at this time and not further analyzed in detail. Since the Fluid Mineral Leasing Screen applies only during RMP planning, that Screen does not apply to the parcels in the Lander planning area. Instead, the management decisions in the Lander RMP have been applied.

Other deferrals were identified for Visual Resource Management (VRM), and Cultural Resources. Deferred parcel areas will remain deferred from leasing until the completion and implementation of the Bighorn Basin Proposed RMP FEIS, at which time the management decisions in the RMP will be applied. As a result, two full VRM and one partial VRM, and one partial Cultural deferral were identified. Overlapping resource deferrals are noted in the table; for example, parcel WY-1602-140 was recommended for both a whole sage grouse deferral and a whole VRM deferral. However, due to potential conflicts with Alternative D of the Bighorn Basin RMP revision and the anticipated timing of the RMP revision ROD prior to the date the sale will be held, all of the parcels located in the Bighorn Basin planning area will be deferred.

43 CFR § 3100.0-3 and the Lander RMP ROD (2014) identified areas which are closed to oil and gas leasing and development. Parcels which were nominated within those areas are deleted and not subject to further consideration, and are so noted in this table.

After the deletion of parcels not open for oil and gas leasing, refer to the EA at 2.4 for a summary table of the number of parcels analyzed, deferred, and proposed to be offered.
